

## YFC Camp Friends -

As some of you know, YFC/USA has developed a really cool partnership with Prison Fellowship/Angel Tree® Program. We have partnered to provide Christmas gifts for not only the teens in local detention facilities but also any young children they may have. We are also working hard to add new JJM ministry sites through Prison Fellowship's strong church relationships. It is an awesome partnership, and we can't wait to reach more teens in tough places moving forward!

Specifically related to YFC Camp, we have partnered with Angel Tree the last few summers to bring a small group of kids from inner city areas to a few camps. **ALSO - Prison Fellowship is able to provide a camping scholarship in the amount of \$250 per camper in 2019 for any kid in your ministry attending YFC Camp OR Project Serve, IF they meet at least one criteria...**

To be eligible for scholarship reimbursement, the camper must be 18 years old or younger **and** meet **ONE** of the criteria below:

- Have been registered for Angel Tree Christmas in 2018 or prior years and appears in the Angel Tree database.
- Currently have an incarcerated parent or step-parent. The parent could be incarcerated in a county, state, federal, or military facility. (You must be able to provide the name of the prisoner parent and the facility where he or she is incarcerated.)
- Currently live in a household with an Angel Tree child or child of an incarcerated parent.
- **(NEW FOR 2019!) Have been recently incarcerated themselves (JJM Students!)**

### IMPORTANT CLARIFICATIONS:

- **ALL SCHOLARSHIPS ARE REIMBURSED BY ANGEL TREE AT THE END OF THE CAMPING SEASON.**
- **If you pursue this scholarship opportunity for qualifying students, ALL MONEY OWED TO YFC CAMP IS STILL DUE ON TIME TO THE NSC. Please plan accordingly.**

### HOW TO APPLY:

#### BEFORE CAMP

1. If you have kids you are planning to bring to YFC Camp this summer who fit any of this criteria, your first step is to have an **"Angel Tree Camp Registration Form"** (downloadable from our website) filled out for each student. **\*\*This is a NEW step for 2019\*\***
2. Next, fill out the "Camping Reporting Form" (downloadable from our website) with those students' information and email both the Camping Reporting Form & the Angel Tree Camp Registration Forms to Janet Okerman at [affiliateteam@yfc.net](mailto:affiliateteam@yfc.net).

#### AFTER CAMP

3. After camp - update your reporting form to reflect the students who actually were able to attend camp and then submit that to Janet Okerman who will submit all affiliate forms to Betsy for scholarship payment.

**\* Reporting forms and camper registration forms are due to Janet by your Housing Form Due Date. The final update to the Reporting Form is due within the first week after camp to Janet Okerman ([affiliateteam@yfc.net](mailto:affiliateteam@yfc.net)). No later than August 19<sup>th</sup>, 2019.**

This is an incredible privilege to be a part of and we are grateful for our developing partnership with Angel Tree! May God use this partnership to see more kids find HOPE in Jesus while at YFC Camp!
